wording required to remember
CBA in your Will...**

“I give, devise and bequeath to Christian Broadcasting Association Trust the sum of \$.....* for the general purposes of the CBA Trust and free of all charges. An official receipt from the CBA Trust signed by one of the Trustees, shall be a sufficient discharge to my Trustee who shall not be bound to see the application thereof.”

*or you may wish to state a percentage, a fraction, an asset or the residue of your estate.

Your Will is valid only if properly prepared and witnessed. After signing your new Will, please be sure to inform us, so we can thank you personally and stay in touch.
